National president also hails from Alabama

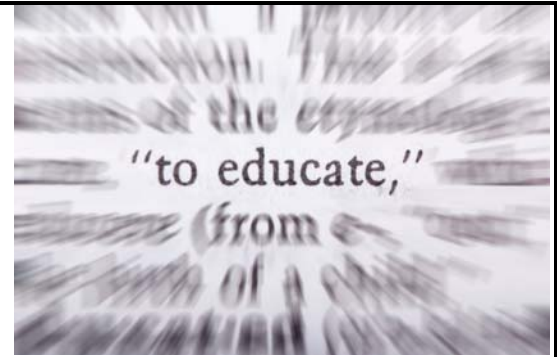

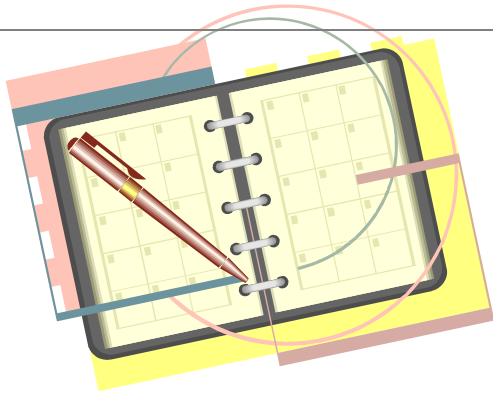

Where are they now? Former FBA leaders in the news

FORMER FBA President Constance S. Barker is completing her first year as a Commissioner of the U.S. Equal Employment Opportunity Commission (EEOC). Barker, who was president of the Montgomery Chapter from 2006-07, was nominated in March 2008 by then-Pres. George W. Bush. After unanimous Senate confirmation, she was sworn in on July 14, 2008 to serve the remainder of a five-year term expiring on July 1, 2011.

In 1996, Barker joined Capell & Howard as a shareholder, focusing on prevention of discrimination complaints and defending clients in employment discrimination lawsuits. Her public-sector experience included four years as assistant district attorney for the 11th Judicial Circuit and later for the 13th Judicial Circuit of Alabama. In 1985, she was hired to the newly created position of in-house counsel for Mobile County Public Schools, that county's largest employer and the 13th largest school system in the nation. She served in that position for 11 years, providing legal advice and counsel to the board and top management on matters involving discrimination, tenure law, contracts and areas of general corporate law. She also served as part-time judge for the towns of Citronelle and Satsuma.



A native of Florence, Barker received a bachelor of arts degree from the University of Notre Dame in 1973. She earned her law degree from the University of Alabama in 1977 and was admitted to the Alabama State Bar that same year. Her husband, Carl, is a former president of the Montgomery Area Chamber of Commerce and is president of Servis First Bank of Montgomery.
