President's Message



As the Dallas Chapter turns the page on yet another fiscal year, I would like to take the opportunity to express the Chapter's appreciation to our Immediate Past President, Jason Bloom, for the many accomplishments he helped us achieve during the 2015-2016 program year. For those of you who were unable to attend this year's Annual Meeting in Ohio, the Dallas Chapter was recognized for exceeding FBA National's membership goals of 5% growth or more. Jason Jordan, last year's Membership Chair, deserves special recognition for all of his efforts on this front. Our

Chapter also received an award for its quarterly newsletter, thanks to the work of our current Vice President, Richard Guiltinan, and several individuals who contributed articles during the course of the year. We have big shoes to fill this year.

I am excited to share several new developments for 2016-2017 that will further enhance our program slate. First and foremost, we will be holding our first annual Northern District of Texas Bench Bar Conference on Friday, January 27, 2017, at the Four Seasons Resort and Club in Las Colinas. While final details are still being ironed out, the current plan is for the conference to last from 9 am to 4:30 pm, followed by a reception. Several judges have already committed to participating in the event, and we anticipate drawing attendees and speakers from all over the Northern District. Be on the lookout for an electronic save-the-date in the near future. In March, we plan to host a CLE event that is specifically targeted to lawyers with a government practice. When the FBA began in 1920, its membership primarily consisted of government employees. Today, the Dallas Chapter has very few government attorneys among our ranks. Our hope is that the government practice event will demonstrate the benefits of FBA membership to local government attorneys and private lawyers who frequently interact with governmental agencies. The topic for the March CLE will be governmental privileges and privacy assertions.

This year, the Dallas Chapter will also participate as one of a handful of pilot chapters in FBA National's SOLACE Initiative. SOLACE, which stands for "Support of Lawyers/Legal Personnel – All Concern Encouraged," is a program designed to enable the FBA community to assist one another when one of our own or someone close to us experiences a death, or some catastrophic event, illness, sickness, injury, or other personal crisis. The program initially started in Louisiana and has gained glowing reviews. Examples of past SOLACE requests that have been answered include everything from securing a medical evacuation airlift from a foreign country to providing a grieving family with meals. SOLACE does not handle requests for money. The program is open to all FBA members and those related to them within the legal community, including judges, lawyers, court personnel, paralegals, legal secretaries and their families. Lisa Lambert, who is a member of the Dallas Chapter and is the FBA National Bankruptcy Section Chair, has graciously agreed to be the Dallas Chapter's SOLACE Liaison.



Dallas Chapter Recognized at Annual Meeting and Convention

The Dallas Chapter was recognized in two categories during the FBA Annual Meeting and Convention, which took place in Cleveland, Ohio, on September 15-17, 2016.

In January 2016, FBA announced a "Countdown to Cleveland Chapter Challenge," with the goal of increasing national membership by 18,500 total members. To facilitate this objective, each chapter was challenged to achieve an individualized membership goal. The Dallas Chapter's goal was to increase its membership by more than 5% between December 31, 2015, and the beginning of the Annual Meeting. The Chapter surpassed this target in early 2016 and maintained an 8% increase over total membership on December 31, 2015. The Dallas Chapter received recognition at the Annual Meeting for this accomplishment, along with the other chapters who reached their membership goals.

The Dallas Chapter's Newsletter also received the "Meritorious Newsletter Award" for 2016 at the Annual Meeting. Last year's Dallas Chapter Secretary Richard Guiltinan accepted a certificate commemorating this achievement. The district judges of the United States District Court for the Northern District of Texas selected D. Gordon Bryant, Jr. to serve as United States Magistrate Judge at the Lubbock Division. Judge Bryant began his service as a magistrate judge on August 1, 2016.

Judge Bryant received a Bachelor of Business Administration degree, with honors, from Baylor University in 1983, and a Juris Doctor degree from Baylor School of Law in 1986. Upon graduation from law school, Judge Bryant became an associate with Gibson, Ochsner and Adkins in Amarillo. In 1991, he was selected to serve as an
