# Chapter Exchange

#### SIXTH CIRCUIT

#### **Northern District of Ohio**

The Northern District of Ohio Chapter teamed up with Magistrate Judge Patricia A. Hemann of the U.S. District Court for the Northern District of Ohio and the Cleveland Bar Association for the second annual "A Book of Your Own" project. Last year, the inaugural year for the project, the Northern District's Younger Lawyer Committee collected more than 5,000 new and gently used books from lawyers in the Cleveland area and gave the books to students at five Cleveland elementary schools for the students to take home and keep as a book of their own. The project garnered the Ilene and Michael Shaw FBA Younger Lawyer Award and Public Service Grant last year.

This year, Judge Hemann challenged the chapter to collect 10,000 books. The chapter took on the challenge, this time with some assistance from the Shaw Grant as well as through an expansion of the project. In addition to collecting books from the Cleveland area legal community, the chapter reached out to suburban schools for help. In the end, the chapter met and surpassed the challenge: members collected 15,000 to give to students at seven Cleveland elementary schools.

In the process of collecting these elementary-level new and gently used books, the Northern District of Ohio Chapter learned that, without trying, it had also collected books to be used at the high school level (800 this year) as well at the preschool level (25 boxes of books). Those books are being delivered to a Cleveland high school and to Cleveland's Rainbow Babies and Children's Hospital. Finally, through an unexpected act of generosity, the chapter received a windfall of 4,000 kindergarten-level books and 4,000 workbooks that were delivered citywide to Cleveland's kindergartners. All told, the chapter distributed approximately 24,000 books to Cleveland's schoolchildren.

The project ramped up again in fall 2006, when members of the Northern District of Ohio Chapter and the chap-

ter's Younger Lawyer Committeeheaded up by Hope Redmond, Ian Redmond, and Kip Bollin-reached out to the Cleveland legal community, including the Cleveland Bar Association, to help collect the books. A point person was identified at dozens of law offices to coordinate the collection of books at his or her office. Next, dozens of suburban schools were contacted and asked to participate, with one hardworking student to receive a \$500 scholarship. More than a dozen schools responded-and even one college joined in. Then, on Jan. 27, dozens more volunteers-including Judge Hemann, members of her staff, students from Laurel School and Cleveland's Daniel Morgan School, and lawyers from the chapter and the Cleveland Bar Associationspent a morning sorting and boxing books in Judge Hemann's chambers. Finally, on March 1, more volunteers from the chapter and the U.S. attorney's office picked up hundreds of boxes of books from the judge's chambers and distributed them to students at seven schools in Cleveland.

The project was a success this year thanks to the dedication of Judge Hemann, her staff, supporters at the donor schools, and the dozens of law firms and individual lawyers who worked to-

gether to collect, sort, box, and deliver the books. Because of their efforts, thousands of Cleveland students now have books to call their own. Now, Judge Hemann challenges other FBA chapters to do the same, saying "Let's make this a national project for the FBA chapters located in every city where there are children who need the friends they can find in books." Clackamas County.


