
Federal Bar Association's Annual Meeting and Convention in September, but I will anyway.

I'd like to highlight some of the events (detailed information is included in the official convention program inserted in this issue). We will be housed at the Ritz Carlton, a wonderful hotel on Canal Street just a step away from famed Bourbon Street and right on the edge of the French Quarter. What more could you ask for in terms of ideal location?

CLE course offerings will include panels on international litigation, international arbitration, health care, and the implications of MRGO litigation. Also on the program are panels on veterans treatment courts and piracy on the high seas-both of which are important and timely issues. We will also hear about New Orleans "Rising from the Ashes" and the historic "Battle of New Orleans" and its implications on legal history and the development of civil law. Speakers include federal court judges, prominent attorneys, distinguished law professors, and a justice of the Irish High Court from Dublin, Ireland. These presentations, along with others on ethics and professionalism, will meet the CLE needs and interests of any attorney. There will be two great receptions that will provide many opportunities for networking with old and new friends, and the meeting will end with the Presidential Installation Banquet, at which New Orleans' own Ashley Belleau will be sworn in as the new president of the FBA.

New Orleans is a destination city. You'll want to come for more than the National Council meeting and the CLE courses. Recognizing that fact, there will be optional excursions in and around New Orleans. A tour of the Crescent City will include visits to the French Quarter, the Garden District, and one of the city's most historic above-ground cemeteries, which are often described as "cities of the dead." You may want to take an excursion to the New Orleans School of Cooking, where you won't just learn about delec-

table Louisiana cooking, but you'll get to eat the results of your lesson. One of my favorite tour offerings is the Honey Island Swamp Tour, during which, from the comfort and safety of a flat-bottom boat, you'll be able to get up close and



New Orleans is famed in music and movies—including "The Big Easy"; "Hard Target"; and, most recently, "The Curious Case of Benjamin Button"—which were all filmed, in part, in New Orleans with the city as their backdrop. This is a tremendous opportunity for the FBA to show support for New Orleans and the recovery effort that is still ongoing from the devastation of Hurricane Katrina.
