# **Puerto Rico**

On July 2, the U.S. District Court for the District of Puerto Rico held an Independence Day Naturalization Ceremony presided by Hon. Gustavo A. Gelpi, district judge. Also sitting were U.S. District Judges Hon. Juan M. Perez-Jimenez, Hon. Daniel R. Domínguez, Hon. Francisco A. Besosa, and Justice Erick Kolthoff-Caraballo of the Supreme Court of Puerto Rico. The group of candidates deemed fully qualified for U.S. citizenship consisted of 100 aspiring citizens from 16 different countries. Symbolic of the concept of federalism and the relationship between federal and state judiciaries was Justice Kolthoff's administering the candidates' oath to defend the Constitution of the United States, to abide by the laws of our nation, and to fulfill the duties that come with their new citizenship.

A milestone in the lifetime of the new U.S. citizens, the ceremony included heartfelt advice and a series of messages ranging from historical accounts on the formation of our nation and the importance of American citizenship to personal anecdotes concerning the diverse heritage of the speakers and the description of their inspiring struggles and

successes. The common thread of the messages was the focus on the values that serve as pillars to the nation's values of equality, liberty, and democracy, as well as the privileges, rights, and responsibilities of all U.S. citizens. Along those lines, the judge's initial remarks were followed by those of Katherine Gonzalez, president of the Puerto Rico Chapter, and the keynote speaker Hans Hertell, former U.S. ambassador to the Dominican Republic. In his speech, Ambassador Hertell noted how the American nation is nurtured and formed by our different cultures and the influence of the country's Hispanic population.

Through Judge Gelpi and Gonzalez, the new citizens were also introduced to the mission and objectives of the Federal Bar Association and specifically the Puerto Rico Chapter—including promoting compliance with the Constitution and laws of the United States and emphasizing the importance of jury duty, among other obligations that come with citizenship.

To underscore the importance of scouting, community service, and early instruction about the values that characterize our nation, a group of Boy Scouts of America from Puerto Rico's Troop 29 was included as guests at the ceremony. The ceremony was filled

with emotions and represented a true celebration of citizenship!
