Government Contracts Section

On July 13, the section held an afternoon audio conference and evening reception, entitled "Can You Say Wassenaar? An Audio Conference on the Proposed Reforms and Likely Shape of the Future U.S. Export Controls System." In April, the administration rolled out the key points of its muchawaited export controls reforms: (1) a single control list (combining the ITAR & EAR lists, like in the Wassenaar Arrangement), (2) a single licensing agency, (3) a single enforcement agency, and (4) a single information technology system. Although the ultimate contours of the proposed reforms are still uncertain because they will require major legislation, the history of the reforms and the existing international regimes that have shaped them provide insight into the likely new system. Accordingly, the FBA's Government Contracts Section was pleased to present an audio conference on the proposed reforms, their history, and the existing international models for them. The discussion was led by Ira Hoffman, who is chair of the International Practice Group at Shulman Rogers, a former adjunct lecturer on international trade law at the George Mason University School of Law, the lead instructor for Federal Publications Seminars' International Government and Commercial Contracting course,

and editor of the forthcoming U.S. Export Controls: The Annotated EAR Desk Reference (West, 2010).

Later that evening, the section sponsored a program entitled "A Summer Social in Honor of the Judges of the Boards of Contract Appeals" in conjunction with the Boards of Contract Appeals Bar Association Inc. and the District of Columbia Bar Government Contracts and Litigation Section. Attendees enjoyed ice cream and gelato at the offices of Buchanan Ingersoll & Rooney while mingling with the judges who attended the event.
