I accept that even consumers of pornography—even consumers of child pornography—are entitled to their rights, but is it really worthy of a "sidebar" account in our publication? (*The Federal Lawyer*, October 2009)

If the subject of the film was just 4 feet 10 inches tall and weighed only 79 pounds so that a customs officer, two Immigration and Customs Enforcement special agents, and two pediatricians believed her to be a minor, then Carlos, the client and hero in the account, could not likely have believed otherwise, himself. He may have been vindicated by the fortuitous fact that she was a legal adult (19 years old), but that doesn't reflect his state of mind in purchasing the DVDs. So while he avoided being classified as a sex offender by the legal system, he remains a predator of the type that designation is meant to identify. Regardless, his "ordeal" is hardly the inspiration I expect in The Federal Lawyer.
