He graduated from law school in 1935 and served as assistant counsel to New York's

Governor Thomas Dewey from 1943 to 1949 and as counsel to the governor from 1950 to 1951. From 1951 to 1953, Judge Walsh served as counsel for the New York State Public Service Commission, and, in 1954, President Eisenhower appointed him to a federal judgeship for the U.S. District Court for the Southern District of

New York. In 1957, Judge Walsh resigned from the bench to become the deputy attorney general of the United States, a position in which he served until 1960. In 1986, Judge Walsh served as the court-appointed independent counsel charged with investigating the Iran-Contra affair during the Reagan administration. He

has published an account of the investigation in his book Firewall: The *Iran-Contra Conspiracy and Cover-up.* Judge Walsh is currently of counsel at Crowe & Dunlevy and was previously a partner at the New York law firm of Davis, Polk & Wardwell.

The luncheon was followed by an informal question-and-answer session, during which Judge Walsh encouraged the law students and young lawyers to pursue careers in public service early on, before becoming partners at various private firms. Judge Walsh said "I enjoyed politics. Enjoyed politics on the street more than politics on Capitol Hill and in committee meetings." His inspirational stories were educational and insightful, and the young attendees enjoyed their time hearing from the 99-year-old judge who continues to exhibit his sharp legal mind. TFL
