James Holderman, chief judge of the U.S. District Court for the Northern District of Illinois; Hon. Gerald Rosen, chief judge of the U.S. District Court for the Eastern District of Michigan; and experienced federal practitioners—after the program. There was so much enthusiasm in the room that the panelists agreed to take their show on the road. And it was standing room only for Dean Erwin Chemerinsky's review of the Supreme Court and for the distinctive panel addressing various Ponzi schemes. Only space restrains me from describing each of the other informa-

tive and interesting programs. This is value!



Convention attendees also had the opportunity to apply for admission to the Seventh Circuit Court of Appeals. More than 20 FBA members took advantage of this opportunity, and they were treated to a unique conversation with Hon. Frank Easterbrook, chief judge of the U.S. Court of Appeals for the Seventh Circuit. And when all the work was done, we entertained ourselves at several happy hours; an evening among the whales, dolphins, and fish at the Shedd Aquarium overlooking the lake (during which we were entertained by the Scales of Justice, a jazz band founded and led by Judge Blanche Manning, a federal judge in the Northern District of Illinois by day and a mighty saxophone player by night); an architectural boat tour down the Chicago River; a stroll through the new modern wing of the Art Institute of Chicago ending with dinner at the rooftop restaurant overlooking Millenium Park and the Lurie Gardens; and a fantastic awards and installation reception and banquet.

Our yearly convention is not the only place where FBA members can benefit from excellent programs presented by experienced practitioners, members of the judiciary, and law professors. These ongoing programs are presented by many FBA chapters and by the FBA sections and divisions and are usually easily accessible, providing opportunities to meet the local judiciary and other practitioners, to ask questions, and to discuss viewpoints. #### Section on Taxation

David Gustafson of the U.S. Tax Court, in which the speaker shared his perspectives on the practice of tax law. The program was moderated by Brian Power of Mayer Brown LLP and Timothy Mulvey of White & Case LLP.

# Transportation and Transportation Security Law Section

The FBA's Transportation and Transportation Security Law Section sponsored a Brown Bag Luncheon on Sept. 13, at the Department of Transportation's Headquarters West Building. The luncheon featured Cheryl T. Rose, senior attorney, Water Enforcement Division, Office of Enforcement and Compliance Assurance, Environmental Protection Agency, and Jim Pates, assistant chief counsel for pipeline safety law, Pipeline and Hazardous Materials Safety Administration, Department of

Transportation. The speakers shared their perspectives on pipeline incidents, including EPA and DOT/PHMSA jurisdictional boundaries and regulatory authority regarding pipeline spills and enforcement as well as areas of collaboration between the two agencies.

#### **Government Contracts Section**

The FBA and the Public Contracting Institute hosted a networking reception with the D.C. chapter of the National Contract Management Association and the George Washington University's Law School chapter of NCMA on Thursday, Sept. 13. The reception had a great turnout and participants said they enjoyed networking with one another.

The Government Contracts Section also hosted an audio conference on Wednesday, Sept. 21. The speaker, Paul Barchie, assistant general counsel, L-3 Corporation, gave a presentation entitled "International Sales Representatives: Compliance and Management Issues." Matthew McGrath, of McGrath Law Group LLC, was the moderator for this discus-

sion. About 40 individuals called in to this audio discussion with Barchie, who spoke on his experience and gave helpful insights on key areas of compliance, typical areas of regulatory focus, and practical approaches to compliance. The topics Barchie touched on included U.S. and foreign law relating to improper payments, reporting requirements under various regulations, and cost allowability issues under U.S. rules. **TFL**

and needs of public and private federal practitioners, members of the federal judiciary, and the public they serve. (Justice Kagan requested the individual meetings in lieu of formal remarks.) Justice Sonia Sotomayor, who was inducted as an Honorary Life Fellow of the Foundation in December 2009, stopped by to wish her colleague the best.

Last spring, through the efforts of our Younger Lawyers Division, all Federal Bar Association members had the opportunity to be admitted to practice before the U.S. Supreme Court. Approximately 90 FBA members took advantage of this event, and they and their guests enjoyed the ceremony as well as a chance to meet with Justice Ruth Bader Ginsberg. When we say the FBA gives you access to the judiciary, we are talking about judges at all levels. This too is value. No other bar association offers such a benefit.
