Section on Taxation

The 36th Annual Tax Law Conference was held on March 2 at the Ronald Reagan Building and International Trade Center in Washington, D.C. Featured speakers at the conference included William J. Wilkins, chief counsel for the Internal Revenue Service, and Nina E. Olson, national taxpayer advocate for the Internal Revenue Service. Conference attendees received an update on tax legislation from chief tax counsel from the Senate Finance and House Ways and Means Committees.

Concurrent sessions throughout the day focused on critical developments in employee benefits and executive compensation. The sessions featured discussions of the impact of the Affordable Care Act on employers and health plans; domestic corporate tax rates, highlighting § 382 and its policy considerations; international law, including topics such as the new Foreign Account Tax Compliance Act and transfer pricing practices; tax practice and procedure, featuring discussion of appellate tax litigation issues; tax accounting and proposed tangible property repair regulations; partnerships and pass-throughs, including limited partner interests; financial products, emphasizing short sale principles and tax rules; enforcement
