Environment, Energy, and Natural Resources Section

On April 18, the Environment, Energy, and Natural Resources Section hosted a webinar on the topic of natural gas development by hydraulic fracturing and the most recently enacted comprehensive statutory scheme addressing regulation of shale hydrofracking. The featured speakers included Elizabeth Nolan, regulatory counsel for oil and gas, Pennsylvania Department of the Environmental Protection, and Scott Perry, deputy secretary for oil and gas management, Pennsylvania Department of the Environmental Protection. The program was moderated by Ken Gelburd, EENR board member and program chair.

Frederick, director, Jury Research Services, National Legal Research Group Inc.; and Collin Hite, partner, Toxic Torts & Environmental Department, McGuire Woods LLP.

Indian Law Section

The 37th Annual Indian Law Conference took place in Santa Fe, N.M., at the Pueblo of Pojoaque on April 19-20. Because maps have played such a vital role in the goals and objectives of Indian affairs, this year's conference focused on the theme of mapping Indian country and the many ways this practice still shapes federal Indian law and policy today.

Panels discussed such topics as digital mapping, which focused on cybercasinos and the use of GIS data to secure sacred sites and target crime; identity mapping, which covered the ideas of defining membership and the impact of a mobile society on Indian country; and boundary mapping, which addressed reservation boundaries and intergovernmental disputes. Other plenary sessions included talks on transboundary resolutions and the Saginaw Chippewa model for intergovernmental jurisdictional agreements; the metes and bounds of laches, focusing on New York land claims and their repercussions; and transportation issues in Indian country. Breakout sessions included specialized panels on federal court nominations and the Indian Child Welfare Act and the codification into state law. The program also included a meeting with the Indian Law and Order Commission. Speakers included respected professionals from private practice, education, and government to help make this year's conference a success.

A tribute to David Getches, a renowned expert on Indian Law issues who passed away last year, took place during the Friday luncheon.
