FOURTH CIRCUIT

South Carolina

On March 22-23, 2012, the South Carolina Chapter held an Appellate Advocacy CLE in conjunction with the Fourth Circuit's historic sitting in Greenville, S.C. At the invitation of the South Carolina Chapter, the Fourth Circuit heard oral arguments in Greenville for the first time in almost 40 years. Retired Supreme Court Justice Sandra Day O'Connor sat as a member of the Fourth Circuit panel on both days of argument, participated in a question and answer session for FBA members, and was the guest of honor at a reception following the CLE. FBA members observed oral argument as part of the CLE, where speakers included Fourth Circuit Chief Judge William B. Traxler Jr., District Judge Michelle Childs, Fourth Circuit Mediator Ed Smith, and Furman University President Rod Smolla. The event was wildly successful, was featured in every major newspaper in South Carolina, and drew the largest crowd to date for a South Carolina Chapter event.

Western District of Virginia

On May 1, the Clerk's Office for the U.S. District Court for the Western District of Virginia held its first Law Day program in Roanoke, Va. Approximately 40 high school and middle school home schoolers were in attendance. Magistrate Judge Robert Ballou and Clerk of the Court Julie Dudley were the hosts. The students learned of duties and responsibilities of the Clerk's Office, the federal judiciary, the U.S. Attorney's Office, the U.S. Probation Office, the U.S. Marshall Service, the defense bar, and the Roanoke Chapter of the FBA.

The presentation included the criminal trial of William H. Bonney, a/k/a Mad Dog. Mad Dog was charged with drug trafficking and use of a firearm during a drug trafficking offense. Pat Hogeboom and a student prosecuted the case. Scott Weber, Josh Johnson, and a student attendee provided a spirited defense, but the student jurors found Mad Dog guilty of all counts and Judge Ballou sentenced Mad Dog to 25 years in prison. Students also played the roles of Mad Dog and Mad Dog's girlfriend turned star government witness, Mercedes Ford. Gwen Mason from the U.S. Attorney's Office played the role of Mad Dog's mother and openly wept when Mad Dog received his 25-year sentence. At each stage of the trial, Judge Ballou would pause the proceedings, allowing the participants to explain what had occurred at each juncture of the proceedings.
