U.S. Attorney General Eric Holder Jr. Participates in Eastern District of New York Chapter Event

On Oct. 30, U.S. Attorney General Eric Holder Jr. participated in a program in the Eastern District of New York (EDNY) addressing the EDNY's Pretrial Opportunity Program and Special Options Services Program, two prison-alternative programs. Hon. Joanna Seybert and Hon. Gary R. Brown, who both serve on the board of directors of the EDNY Chapter, are two of the judges who preside over the Pretrial Opportunity Program, running the program in the Central Islip Courthouse. Attorney General Holder offered high praise for the two EDNY programs, hailing the Pretrial Opportunity Program as "emblematic of the innovative, data-driven approach that lives at the heart of the Smart on Crime initiative." The Pretrial Opportunity Program was established in the EDNY in 2012 with a goal of taking nonviolent offenders with documented substance abuse problems out of the traditional sentencing and incarceration paths and providing them with counseling and improvement programs, such as earning a graduate equivalency degree, obtaining employment, or gaining college admission. Participants in the programs gave emotional and inspiring speeches as to their experiences with addiction and how the programs saved their lives. The Oct. 30 program was very well-attended and -received, including by many members of the EDNY Chapter.

Alaska's U.S. senators, Mark Begich and Lisa Murkowski. Gelpi moderated several programs at the conference and also presented a historical overview on the development of constitutional law in current and former U.S. territories, such as Alaska, Hawaii, and Puerto Rico. A panel presentation marking the 50th anniversary of the Criminal Justice Act featured Alaska Chief Judge Ralph Beistline, Federal Public Defender Rich Curtner, and U.S. Attorney Karen Loeffler. Joshua Decker, the executive director of the ACLU of Alaska, presented a retrospective talk on the 50 years following the passage of the Civil Rights Act. Lunch included a presentation on current efforts to establish equal rights for Americans in U.S. territories by Neil Weare, president and founder of the We the People Project based in Washington, D.C. In the afternoon, a halfday CLE on federal sentencing was given by Alan Dorhoffer, deputy director of the office of education and sentencing practice of the U.S. Sentencing Commission, and included a moderated panel discussion with Alaska's three active district judges. The event concluded with a gala reception.

At the annual national meeting and convention in Providence, Rhode Island, Gelpi had high praise for the Alaska conference and encouraged FBA members to consider attending the Second Annual Alaska Federal Bar Conference in 2015. Although the exact date has yet to be announced, it will likely be on a Friday in August, offering conference attendees the opportunity to stretch out their trip and

North Central Florida Chapter Holds Annual Meeting and Reception

On Sept. 18, the North Central Florida Chapter of the FBA held its annual meeting and reception in the Advocacy Center of the University of Florida College of Law in Gainesville. Outgoing president Ron Kozlowski brought the membership up to date on the chapter's achievements over the past year, including winning two honors from FBA's national headquarters: a Chapter Community Outreach grant from FBA's national headquarters and a Presidential Excellence Award.

The grant was given for a writing competition open to all University of Florida law students based on the approaching 50th anniversary of *New York Times v. Sullivan*, asking students to discuss the shift in judicial and legislative attitudes toward a free press and the possible consequent danger to civil rights.

Nine federal judges and nine prominent attorneys from around the state descended on Gainesville to discuss leadership issues facing women in the legal profession. After a short panel discussion, moderators led each table

in a focused conversation on the ideas and questions raised by the panelists.

Kozlowski then presented a Chapter Service Award to Stephanie Marchman, a past president and membership chair. Marchman has spent many years on the board working hard to put on excellent events, increase membership, and pitch in wherever needed. Her energy and institutional memory have been crucial to the chapter's success.

After Mickle swore in the new board members, incoming President Peg O'Connor gave the audience a peek at the events planned for the upcoming year, including a breakfast and symposium with Professor Erwin Chemerinsky, brown bag lunches with federal judges, a second leadership roundtable, and other exciting happenings.

O'Connor had the honor of presenting a Federal Service Award to her former coclerk, Midori Lowry, recognizing 16 years of dedicated service to Judge Mickle as his career clerk. Lowry was with the judge on his first day on the bench in August 1998, and she stayed with him until his last day in September 2014.

As the highlight of the evening, Northern District U.S. Attorney Pam Marsh sent Assistant U.S. Attorney Corey Smith from Tallahassee to present Mickle with a letter from U.S. Attorney General Eric Holder, commending the judge for his "passion for the rule of law and ... fidelity to those whom the law protects and empowers."
