#### Mark K. Vincent, President



Mark K. Vincent is a 17-year active member of the Federal Bar Association and a fellow of the FBA Foundation. Vincent is also a 24-year veteran of the U.S. attorney's office, District of Utah

Vincent is a leader in the FBA, serving as a board director (2006–10); vice president for the circuits (Tenth

Hon. Michael J. Newman was appointed as a magistrate judge in the Southern District of Ohio in July 2011. Prior to his appointment to the bench, he worked as a partner and chair of the labor and employment appellate practice group of Dinsmore & Shohl LLP's Cincinnati, Ohio, office. He also created and ran his firm's pro bono pro-

gram in the U.S. Circuit Court of Appeals for the Sixth Circuit.

His commitment to the FBA is long-standing and includes service for two terms as a vice president for the Sixth Circuit. He previously served as president of the Cincinnati–Northern Kentucky Chapter. He was recently appointed by President Robert DeSousa to chair the FBA Task Force on Elections.

For more than 10 years, he has served on the Editorial Board of *The Federal Lawyer*. In his current role as judicial profiles editor, he has responsibility for all of the judicial profiles that appear

in the magazine. Judge Newman is a prolific author; while in private practice, he co-wrote the monthly Labor & Employment Law column in *The Federal Lawyer* for several years. His other FBA activities include service on the Chapter Activity Fund Committee; co-chair of the Conference Leadership Training & Agenda Committee (charged with responsibility over the programming of both the midyear meeting and the Chapter Leadership Training program offered to all incoming chapter presidents from around the country); and co-chair of the Professional Ethics Committee.

Judge Newman's long-standing commitment to diversity within the bar includes service in Cincinnati as secretary of the Roundtable, a joint effort by the Cincinnati Bar Association and the Black Lawyer's Association. He now serves on the Federal Magistrate Judges Association Diversity Committee as well as the Diversity Committee of the U.S. District Court for the Southern District of Ohio.

Judge Newman was honored by the FBA on three occasions: in 2007, he was given an Outstanding Service and Recognition Award for leadership within the Sixth Circuit and nationwide; in 2009, he was awarded, along with other circuit vice presidents, with an FBA Recognition Award for service as a vice president for the Sixth Circuit; and in 2010, he was humbled to be awarded the Elaine R. "Boots" Fisher national public service award "in recognition of exemplary community, public, and charitable service." He is a fellow of the Foundation of the Federal Bar Association. #### **Kip T. Bollin,** Treasurer

#### W. West Allen



W. West Allen currently serves as chair of the FBA's Government Relations Committee. He served one term as a national director of the FBA from 2011–14. He was a circuit vice president for the Ninth Circuit from 2007–13, overseeing its 16 FBA chapters. During that time, Allen was elected twice by peers to serve as chair of the
