### North Central Florida Chapter Brown Bag Lunch with U.S. Chief Bankruptcy Judge Karen K. Specie

A Brown Bag Lunch with United States Chief Bankruptcy Judge Karen K. Specie was hosted by the North Central Florida (NCFL) Bankruptcy/UCC Committee Chapter of the FBA at the U.S. Courthouse in Gainesville, Florida, on March 4, 2016. Robert Griscti, chapter president, moderated the informative discussion with Chief Judge Specie.

Practitioners from the bench and bar of the Gainesville Division, Northern District of Florida, as well as representatives of the University of Florida Levin College of Law and the Northern District of Florida Bankruptcy Bar Association attended the lunch. Chief Judge Specie educated the audience with advice and anecdotes from her nearly four years as a chief bankruptcy judge, 30 years of private practice, and long-standing service as an adjunct professor of law at the University of Florida Levin College Of Law, where she teaches two courses: "Creditors' Remedies and Bankruptcy" and "Secured Transactions." Chief Judge Specie discussed the challenges of presiding over the geographically widespread Northern District, which has four divisions, two time zones and only one bankruptcy judge. She had nearly 3,000 cases pending as of February 2016.

Chief Judge Specie was a founding member of the NCFL Chapter of the FBA and the Northern District of Florida Bankruptcy Bar Association. In March 2011, Judge Specie was inducted as a fellow into the American College of Bankruptcy. Before taking the bench, Judge Specie served
