yers." The event discussed such topics as the new § 199A pass-through deduction and the current state of meals and entertainment deductions. ☺

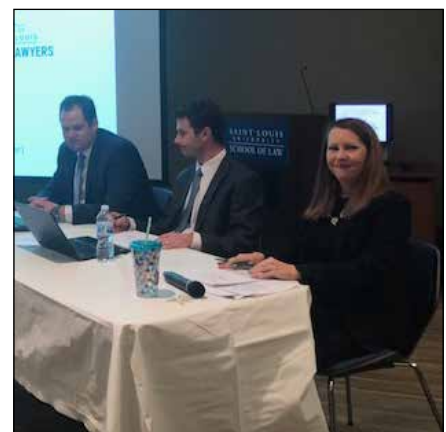
