(The U.S. Court of Federal Claims is located on Madison Place between Pennsylvania Avenue and H Street, NW, on the east side of Lafayette Square across from the White House, in downtown Washington, DC. Take METRO's **Blue Line** (Franconia-Springfield) or the **Orange Line** (Vienna-Fairfax) to the McPherson Square Station. Follow the exit signs toward the White House. At the street level take Vermont Avenue (go left at the top of the escalator) in the direction of H Street. Crossing H Street, Vermont Avenue becomes Madison Place. The Courthouse's main entrance is mid-block on the east side of the street).
