### FBA Welcomes in the New Admittees at the Colorado Supreme Court Admission Ceremony

On October 29, 2012, FBA Colorado Chapter Board Member David Fogel represented the Chapter at the Colorado Supreme Court Admission Ceremony for those who passed the July 2012 bar exam. The event was held at the Boettcher Concert Hall in Denver, Colorado, during which an estimated 800 new attorneys took the Oath of Admission. Admittees were welcomed by Chief Justice Michael L. Bender who presided over the ceremony, while CBA president Mark Fogg welcomed the new attorneys to the practice of law. Judge Russell Carparelli was presented with the ABA Civility Award. \*

### Commission on the Legal Profession Update Mimi E. Tsankov

The FBA Colorado Chapter continues to be very active in the work of Colorado Chief Justice Michael Bender's Commission on the Legal Profession. On January 11, 2013, Chief Justice Bender gave to the distinguished members of the General Assembly a speech on the State of the Judiciary. He reported that the Commission has, among other things:

- Assisted in the creation of the Colorado Bar Association's Colorado Lawyers for Colorado Veterans program which represented 275 indigent veterans;
- Initiated a statewide mentoring program with more than 150 mentors to improve the quality of legal service provided by young lawyers;
- Assisted in the planning and staffing of new selfhelp centers in many courthouses throughout the state; and
- Developed a legal professionalism month, which resulted in more than 50 programs throughout the state concerning professional and ethical conduct for attorneys. \*

FBA Circuit Vice President Robert E. Bacharach Cleared for a Full Senate Vote

The Honorable Robert E. Bacharach's nomination to be a judge on the 10th U.S. Circuit Court of Appeals is back before the full U.S. Senate. On February 7, 2013, the Senate Judiciary Committee cleared Judge Bacharach, who is currently a sitting U.S. magistrate judge in Oklahoma City. Judge Bacharach also serves as an FBA 10th Circuit Vice President. While he has strong bipartisan support, his nomination was stymied eight months ago by presidential politics as Republicans blocked votes on circuit court nominees. A new Congress was convened in January, and as result Judge Bacharach's nomination had to be resubmitted. 🌣

The Colorado Chapter is proud to announce that it was recently awarded a National FBA Grant to support the "For This Stand" **Joint** upcoming First-Year Law Student Orientation Event scheduled for Saturday, September 21, 2013. The event was held for the first time last year, and the FBA Colorado Chapter was also a National FBA Grant recipient for that event, as well.

Created by Colorado Supreme Court Chief Justice Michael L. Bender's Commission on the Legal Profession in 2012, the program involves a half-day professionalism orientation for all 460 of Colorado's first-year law students, with involvement of approximately 75 prominent members of the state and federal judiciary, the state and federal bar, and the faculty of Colorado's two law schools


