



- Be careful with phrasing and terminology;
- Screening for eligibility AND ineligibility;
- Screen for inadmissibility (and waivers);







THINGS TO WATCH OUT FOR:

- Pay attention to detail AND focus on the big picture;
- Re-screen at every step of the process;
- Screen for alternative relief (your Plan B and Plan C);
- Screen for derivative status.

Hypo 1: Rodolfo wants to petition for his mom and dad now that he's 21. Mom entered EWI and dad's most recent entry was with an H-2B.

What do you do?

- A. Open an adjustment for dad and nothing for mom
- B. Do a FOIA on dad
- C. Clarify dad's history
- D. Open an adjustment for dad and an I-130 for mom

FAMILY-BASED & CITIZENSHIP CASES

- Look beyond petitioner-beneficiary family relationship;
- Focus on immigration & criminal history;
 - Review all entries & departures from U.S.

SCREEN FOR LESS-COMMON SCENARIOS

- Relief for members of the military and their family;
- Derivative/acquired citizenship and expedited citizenship;

SCREEN FOR LESS-COMMON SCENARIOS

Hypo: Pritesh is a USC who wants to petition for his pregnant wife to come to the US from India. He has only been a citizen for 2 years.

What do you do?

- A. Bring baby over as a follow-to-join
- B. File for report of citizen born abroad
- C. File an I-130 for the baby once baby is born

SCREEN FOR LESS-COMMON SCENARIOS

- Protections for surviving relatives (ie Special Immigrant widow(er)s, humanitarian reinstatement, INA 204(I))
- Existing protections for now-closed programs (ie INA 245(i), Western Hemisphere Priority Dates, NACARA]
 AND MORE...

SCREEN FOR LESS-COMMON SCENARIOS

Hypo 1: Luis petitioned for his wife and sons to adjust status. His oldest son Oscar gets arrested for marijuana possession and doesn't get his greencard with his mom and brothers. Luis is tragically murdered before Oscar's case is resolved.

Can you continue the case?

EMPLOYMENT-BASED CASES – Part 1:

- Explore education/training background;
- Ask for a CV/resume and discuss work history;
- Ask about long-term plans (and family members);

EMPLOYMENT-BASED CASES – Part 2:

- Keep inadmissibilities in mind;
- When NIV is not possible, look into permanent residence options, and vice versa.
- INA § 245(k)

Screening for asylum and/or withholding of Removal:

- Fear of going back to country of origin
 - Firm resettlement
- One year deadline
- Requesting a CFI/RFI
- Risks of applying for asylum affirmatively
- Bars to Asylum and withholding of Removal
 - Material Support
 - Relief under CAT

INA § 101(a)(42)—Refugee definition INA § 208—Asylum (eligibility and procedures) INA § 235—Expedited removal INA § 241(b)(3)—Withholding of removal

The T Visa: Helping Some Victims of Trafficking

- Severe form of human trafficking (sex and labor trafficking)
 - Force, fraud, or coercion
- Law enforcement cooperation but not necessarily certification
 - Continued Presence
- In the US on account of trafficking
- Inadmissibly waiver under INA§ 212 (d)(13)
 - Some grounds do not apply (e.g.: Public Charge)
- Derivatives Screen for derivative status!!!
 - Spouses and children
 - Parents and minor siblings for applicants under 21
 - Children of derivatives if they face danger due to the trafficking
- Non-immigrant visa with a path to LPR status (INA § 245(m))!

HYPO/POLL:

As she is about to leave your office, Veronica asks you to help her son because she does not want him to go through what she has gone through. You ask Veronica to elaborate. She explains that she left El Salvador when Cristobal was about 8 years old to escape an abusive relationship. She confided in Olga, an older woman who often bought pupusas from Veronica. Olga told her that her cousin, Oscar, owned a restaurant in Houston and could give her job there. Oscar would pay for her passage to the US and she could pay him back as she worked at his restaurant. Veronica saw this as the opportunity of a lifetime.

As soon as Veronica arrived in Houston, she met Oscar and his wife, who took her to a house where she was to share a room with several other young women. She was given revealing clothes to wear and taken to the restaurant which turned out to be a cantina.

Veronica was expected to entertain customers and eventually engage in commercial sex acts. She, and the other women, were watched constantly and when not working, they were in the house, under lock and key.

After being a prisoner for about a year, one of her customers, John, fell in love with her. Veronica also liked John because, although he paid for time with her, he was nice and talked with her. She eventually confided that she was not working at the cantina of her accord. John devised a plan to rescue her and a few days later helped her escape.

Eligibility for Relief under the Violence Against Women Act

- Marriage to a USC or LPR
 - Common law marriage
 - Bigamy
 - Divorce
 - Loss of status
- Don't forget Parents of USCs
- Children are eligible as principals and as derivatives
- Inadmissibility
 - EWI is an exception
 - Found in INA § 245(a) AND in in INA § 212(a)(6)
 - Special waivers
 - Inadmissibility linked to the abuse

Eligibility for Relief under the Violence Against Women Act

- Abuse/extreme cruelty means:
 - Physical
 - Mental
 - Financial, etc...
- Joint residence and abuse can be abroad
- Standard of proof: any credible evidence
 - 8 CFR § 204.2(c)(2)(i)

generally, do not trust the regulations! They have not been properly amended to reflect changes made over the years

The U Visa: Protecting Victims of Crime

- Law Enforcement Certification
 - Qualifying crime
 - Discretion
- Inadmissibly generous waiver under INA § 212(d)(14)
- Derivatives Screen for derivative status!!!
 - Spouses and children
 - Parents and minor siblings for applicants under 21
- Non-immigrant visa with a path to LPR status (INA § 245(m))!
 - Family members (after acquired spouse) with the I-929
- Downsides

Special Immigrant Juvenile Status

- Children path to citizenship
- Abuse, abandonment, or Neglect by one or both parents
- State Court Order
 - Jurisdiction
 - Age
 - Other courts
- Inadmissibility applies
 - Special exemptions
- Inability to later petition for parents, even non-abusive parent
- Area of law in flux
