A. Sampling to prove FCA liability

- 1. There is a split of authority on whether sampling can be used to prove FCA liability.
- 2. Tysons Foods, Inc. v. Bouaphakeo, 136 S. Ct. 1036 (2016). Supreme Court has held permissibility of sampling depends "on the degree to which the evidence is reliable in proving or disproving the elements of the relevant cause of action."
- 3. United States ex rel. Michaels v. Agape Senior Community, Inc., 848 F.3d 330 (4th Cir. 2017). Did not provide the hoped-for guidance on use of sampling to prove liability.
- 4. *United States ex rel. Wall v. Vista Hospice Care, Inc.*, 2016 WL 3449833 (N.D. Tex. June 20, 2016). Court rejected extrapolation to prove the falsity of hospice claims.
- 5. *United States v. Life Care Centers of America, Inc.*, 114 F. Supp. 3d 549 (E.D. Tenn. 2014). Court permitted use of sampling to establish liability.
- 6. United States ex rel. Ruckh v. Genoa Healthcare, LLC, 2015 WL 1926417 (M.D. Fla. Apr. 28, 2015)
